A Consulting Agreement is for farmers and consumers who have a philosophical objection to becoming members in an organization that engages in litigation. Examples of persons requesting Consulting Agreements include those of the Mennonite, Amish or other Anabaptist faiths.

Non-Member Consulting Agreements provide access to qualified legal and operations advice about direct-to-consumer sales/distribution.

Agreements are renewable, and for a minimum term of one year. The fee is \$125 and includes, for farmers, a copy of the *Raw Milk Production Handbook* by Tim Wightman.
